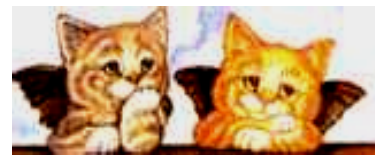


# MYTHS AND FACTS ABOUT CAT DECLAWING

**MYTH #1:** AFTER DECLAWING, A CAT IS LIKELY TO BECOME FEARFUL OR EXPERIENCE BEHAVIOR CHANGES IMPAIRING AN AFFECTIONATE RELATIONSHIP WITH ITS OWNER

---

**FACT:** Declawing causes no increase in behavior problems. <sup>1, 2, 3, 4, 5, 6</sup> A study of found declawing successfully met or surpassed cat owner expectations. <sup>1</sup> 96% reported complete satisfaction and over 70% of the cat owners indicated an improvement in the cat-owner relationship. <sup>1</sup>



**MYTH #2:** A DECLAWED CAT CANNOT CLIMB TREES

---

**FACT:** Declawing does not prevent tree climbing. 40% of cat owners reported allowing their declawed cats outside, even after being advised not to do so and stated these cats still climbed trees, hunted, and successfully defended themselves against other cats and dogs. <sup>1, 2</sup>



**MYTH #3:** A DECLAWED CAT CANNOT CATCH PREY.

---

**FACT:** Studies found declawing does not prevent effective hunting. <sup>1, 2</sup>

**MYTH #4:** A DECLAWED CAT LOSES ITS ABILITY TO DEFEND ITSELF AND SHOULD NOT BE ALLOWED OUTSIDE

---

**FACT:** Studies found declawed cats still hunt and successfully defend themselves against other cats and dogs. <sup>1, 2</sup>



**MYTH #5:** DECLAWED CATS ARE MORE LIKELY TO BITE SINCE THEY CAN NO LONGER CLAW

---

**FACT:** In a study of over 850 cats, declawed cats were no more likely to bite than clawed cats. <sup>4</sup>



**MYTH #6:** THE POST-OPERATIVE PERIOD INVOLVES TREMENDOUS PAIN.

---

**FACT:** Veterinarians are now able to make recovery from declaw surgery easier by using medication to control post-surgical pain. Despite short-term pain and discomfort, there is no scientific data to support claims declawing has any long-term negative effects on a cat's health and well-being. <sup>1, 2, 8</sup>

## MYTH #7: A DECLAWED CAT WILL NOT USE A LITTER BOX AGAIN

**FACT: Declawed cats do not lose their litter box instinct. While some cats may not like using the strips of newspaper veterinarians recommend placing in the litter box temporarily after surgery, there is no evidence declawing causes long-term litter box problems.**<sup>1</sup>



## MYTH #8: A DECLAW BAN WILL NOT HURT CATS

**FACT: 50% of owners of declawed cats state they would not have kept their cats had they not been declawed.**<sup>2</sup> This is consistent with other studies that examined reasons for surrendering a cat to an animal shelter. Behavior problems (including scratching) is a major reason for surrender,<sup>5</sup> while being declawed decreased the risk of relinquishment.<sup>6</sup>



## MYTH #9: A DECLAW BAN IS COST NEUTRAL TO THE CITY

**AVMA formula estimates 994,157 cats in the City of Los Angeles.**<sup>9</sup> **25% (248,539) of these cats are declawed.**<sup>10</sup> **50% (124,269) of these cats would be relinquished if declawing was not an option.**<sup>2</sup>

**A Declaw Ban could cost the City of Los Angeles \$24,261,037.**<sup>11</sup>
